#### Dear Dr Mantilla

I refer to your recent application for provider numbers.

Your eligibility to access Medicare benefits has been assessed in accordance with the legislative provisions in the *Health Insurance Act 1973* (the Act).

From the information provided you are an overseas trained doctor or a foreign graduate of an accredited medical school and subject to certain restrictions on attracting Medicare benefits for your professional services under section 19AB of the Act.

As a permanent resident or Australian citizen you are also subject to certain restrictions under section 19AA of the Act. You must hold either a recognised post-graduate qualification or participate in an approved program under section 3GA before being able to attract Medicare benefits for your professional services.

## Application of Section 19AA

Medicare has received advice from the **Rural Workforce Agency** that you have an approved 3GA placement which enables you to satisfy the restrictions of section19AA of the Act.

You have been placed on the Register of Approved placements for the period 3 June 2013 to 2 June 2014.

Please take note of the placement expiry dates as reminders are not sent by the Department of Human Services Medicare.

If you intend to remain at the locations you must apply for a new 3GA placement prior to the expiry date. The Department of Human Services Medicare cannot backdate placement registration.

#### **Application of Section 19AB**

An exemption under section 19AB of the Act has been granted for a specific period and locations by the Department of Health and Ageing. A copy is enclosed for your records.

If you intend to remain at the locations beyond the expiry date you will need to apply for a new section 19AB exemption at least 28 days prior to this date.

An application for an exemption can be made through the Department of Human Services Medicare to the Department of Health and Ageing using the provider number application form and attaching supporting documentation.

# EXEMPTION UNDER SECTION 19AB OF THE HEALTH INSURANCE ACT 1973 FOR A PERMANENT RESIDENT/AUSTRALIAN CITIZEN MEDICAL PRACTITIONER

Thank you for your application for an exemption under section 19AB of the *Health Insurance Act* 1973 (the Act) received on 27 May 2013.

Because you were first recognised as a medical practitioner in Australia after 1 January 1997, you are subject to the ten year moratorium on overseas-trained doctors. Therefore, this exemption is necessary to enable you to attract Medicare benefits for the professional services you provide.

The delegate representing the Minister for Health has considered the information provided in your application, and I am pleased to inform you that the application has been successful. Please familiarise yourself with the particular conditions pertaining to your exemption and retain the document for future reference.

It is important that you note that the exemption is location and time specific. In addition, it is your responsibility to ensure that your medical registration and visa are current. Failure to do so may result in your deregistration by the Medical Board of Australia.

This exemption has effect from 03 June 2013 to 02 June 2014. It ceases to have effect if you leave Australia.

If you require an extension to this exemption beyond the stated time period or you wish to apply to practice at another location you should contact the Department of Human Services - Medicare. Please ensure that you allow sufficient time for examination and consideration of future requests. This process may take up to 28 days. Applications are processed according to the date of receipt. It is your responsibility to ensure your exemption is current. Exemptions cannot be backdated under any circumstances.

### **HEALTH INSURANCE ACT 1973**

# **EXEMPTION UNDER SECTION 19AB**

I, Paul Gorman, delegate of the Minister for Health, under a delegation made under the *Health Insurance Act 1973* (the Act), pursuant to section 19AB of the Act hereby approve an exemption for Dr. Anecito Mantilla ('the doctor').

This exemption is subject to the conditions that:

- a) the doctor remains a legally qualified medical practitioner in the State or Territory where he or she is practising medicine; and
- the doctor is practising medicine in accordance with any conditions lawfully imposed upon him or her by a State or Territory Medical Board, or other professional registration authority, and not otherwise; and
- c) the doctor remains in an approved 3GA placement under the Rural Locum Relief Program at the location(s) in the following schedule; and
- d) the doctor is practising as a medical practitioner at the address or addresses listed in the schedule to this exemption and does not provide professional services other than in connection with his or her practice at that address or those addresses; and
- e) the doctor must inform the Department of Human Services Medicare:
  - i) if he or she proposes to, or does, leave Australia; and
  - ii) of any change in his or her visa arrangements;
- f) this exemption has effect from 03 June 2013 to 02 June 2014.
